MERP includes an Emergency Communication System (Two Way) that provides direct emergency notices to be sent instantly to all facility staff as well as specific emergency personnel.

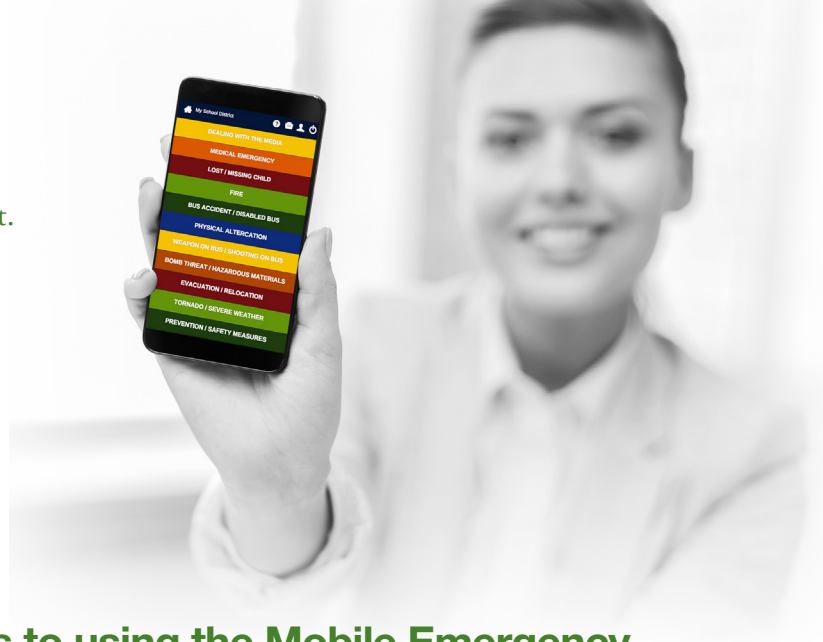
Imagine being able to make an update to your emergency response plan and instantly push it out to all employees and facilities with the touch of a button. Safeguard’s MERP makes that possible.
